## Jukes, Bramante highlight 25<sup>th</sup> annual conference in Savannah

Ian Jukes, director of the InfoSavvy Group, and Fred Bramante, the longest standing member of the New Hampshire State Board of Education, will highlight the 2010 Annual Conference in Savannah, Georgia, December 1-4.

Named one of the top educational speakers in the country, Jukes' rambunctious, irreverent and highly-charged presentations emphasize many of the practical issues related to restructuring to meet the needs of students. AESA has also invited former U.S. President Bill Clinton to serve as our keynote speaker on Saturday. As Governor of Arkansas, Clinton played a vital role in promoting the Arkansas Education Service Cooperatives.

## **AESA Executive Council nominations now open!**

Each year the Association of Educational Service Agencies (AESA) shares with its members the Call for Executive Council Nominations. As president of AESA, I ask that you think about serving on the council.

AESA is a respected and growing organization. We have a very strong association agenda for this year that includes work being conducted by the following committees: membership services, governmental relations, business relations, research and development, and the global education ad hoc committee. The annual conference in early December has grown exponentially over the last decade. I believe this growth is due to the hands-on efforts of our members and executive council. The annual conference, as well as other association activities are organized by AESA members.

While there is an expectation of real involvement and, yes, actual hard work; personal and professional growth by council members is significant. It is an experience that council members enjoy very much.

AESA Bylaws, Article III, Section (b) states "In order to maintain 12 council members and have four-year terms of office each region elects council members three out of four years. The election sequence will be determined by the council with each region having a bye every four years." This year the Eastern Region has the bye and will not have a nominee. The states in the Eastern Region are Connecticut, Indiana, Maryland, Massachusetts, New Hampshire, New Jersey, New York, Ohio, Pennsylvania, Rhode Island and Vermont. These states will, however, have the opportunity to vote in the national election. This year's national nominations must come from the Central, Western and Southern regions.

found on the AESA Website <a href="http://www.aesa.us">http://www.aesa.us</a>. Nominations, biographical statements, signed pledge letter, and a digital picture are to be sent to Peter C. Young, AESA Chief Financial Officer, 53 Hotchkiss Grove Rd., Branford, CT 06405-5409 on or before September 10, 2010.

AESA is your voice at the national level. By linking the local, regional, and national activities into a strong network representing ESAs throughout the country, we have become the fastest growing and one of the most influential educational associations in America. This success has been the direct result of outstanding leadership on the AESA Executive Council.

AESA is governed by a twelve/thirteen member body including twelve council members and the immediate past president. The past president, depending on whether he/she was elected in the third or fourth year of his/ her term, will either be the twelfth or thirteenth member. In order to maintain twelve council members and have four-year terms of office, each region will elect council members three out of four years. The election sequence was determined by the council with each region having a bye every four years. This year the Eastern Region does not elect a council member.

### The AESA regions are:

- Central: Illinois, Iowa, Michigan, Minnesota, Nebraska, North Dakota, South Dakota, Wisconsin.
- Southern: Alabama, Arkansas, Florida, Georgia, Kentucky,

- Louisiana, Mississippi, Missouri, North Carolina, South Carolina, Texas, Virginia, West Virginia.
- Western: Alaska, Arizona, California, Colorado, Hawaii, Idaho, Kansas, Montana, New Mexico, Oregon, Utah, Washington, Wyoming.
- Eastern (Bye No Council nomination this year): Connecticut, Indiana, Maryland, Massachusetts, New Hampshire, New Jersey, New York, Ohio, Pennsylvania, Rhode Island, Vermont.

## **Current Council Members by** region are:

- Eastern: James Baldwin, New York (President-Elect); Dan Hare, Ohio; and Marjorie Wallace, Pennsylvania.
- Central: Bruce Dennison, Illinois; Cliff Carmody, Minnesota; Mick Loughran, Nebraska; Joeseph Crozier, Iowa (Past President).
- Western: R. Stephen Aguirre, New Mexico; Dee Alarcon, California (President); Mike Cook, Kansas.
- Southern: John Bass, Texas; Dee Cockrille, West Virginia; Lindy Franks, Arkansas.

Each state may have only one voting representative on the council at a given time. Therefore, states with current council members cannot have a council member elected from their state this year. However, those states may nominate persons for the council.

No state shall be represented by an elected member on the council for more than four consecutive years, except in the case of the past president where the past presidency may occur in his/her fourth or fifth year, depending on the year he/she was elected president.

Council members may not serve consecutive terms of office. The state whose council member serves as past president is ineligible during the year of the past presidency.

# Nominations now open for Prentice, Turner Stephens, and Talbott national awards

Nominations for AESA's four national awards to recognize individuals for outstanding contributions to educational service agency programs at the regional, state, and national levels are open and will close on Friday, August 6. The awards will be presented at the 2010 Annual Conference, December 1-4 at Savannah, Georgia.

Following are descriptions about each of the AESA national awards:

#### **Justus A. Prentice Award**

The Justus A. Prentice Award is given to an individual for contributions through executive leadership in the advancement of educational service agency programs at the regional, state, and national levels. Criteria for the award are: 1. Advancement of the goals and philosophies of educational service agencies; 2. Outstanding accomplishments and innovative practices; 3. Exercise of leadership; and, 4. Service to educational service agencies.

Nominees have included past or present educational service agency executives and staff. The 2009 Justus A. Prentice Award was presented to Dr. William McKinney Executive Director of Region 4 Education Service Center at Houston, one of the largest ESAs in the United States.

#### **Walter G. Turner Award**

The Walter G. Turner Award is given to an individual citizen who has made outstanding contributions in the advancement of educational service agency programs at the regional, state, and/or national levels. Criteria for the award include: Advancement of the goals and philosophies of educational service agencies; 2. Outstanding accomplishments and innovative practices; 3. Exercise of leadership; and, 4. Service to educational service agency community.

Nominees could include board members, state/national legislators, and local/state/national educators, and professional association staff. The 2009 Walter G. Turner Award was presented to Michael P. Flanagan, Michigan State Superintendent of Public Instruction. Flanagan previously was a K-12 superintendent of the largest ESA in Michigan, executive director of the Michigan Association of School Administrators and the Michigan Association of Intermediate School Administrators.

#### **E. Robert Stephens Award**

The E. Robert Stephens Award is given to an individual(s) whose research advances the understanding of educational service agencies at the regional, state, and/or national levels. The work(s) may include, but is (are) not limited to: articles, monographs, dissertation, a book chapter or a book. Nominees could include any individual whose work(s) meet(s) the intent of this award and adds to the research base on educational service agencies. Criteria for the award include: 1. Advancement of the goals and philosophies of educational service agencies; 2. Scholarly nature of the work(s); and, 3. Impact of the research on educational service agencies.

Nominees could include any individual whose work(s) meet(s) the intent of this award. The E. Robert Stephens Award was not presented in 2009.

#### **Brian L. Talbott Award**

The Brian L. Talbott Award is given for outstanding contributions through innovative technology support to constituent schools that caused positive improvement to be made, and through the effective use of technology to enhance the agency's own operation and accountability. Criteria for the award include: 1. Advancement of the goals and philosophies of educational service agencies; 2. Evidence that agency/person has provided innovative technology support to constituent schools in the areas of instruction and/or business management that has caused positive improvement; and/or 3. Evidence that the agency/person has effectively used technology for enhancing the agency's own operation and accountability.

The 2009 Brian L Talbott award was presented to Geoff Craven, Telecommunications and Technical Support Manager of Central Susquehanna Intermediate Unit in Pennsylvania.
