Executive Council nominations are now open!

Each year, the Association of Educational Service Agencies (AESA) informs our membership of its Call for Executive Council nominations. As the current President of AESA, I am sending along my personal invitation to consider serving your association as a member of the Executive Council.

As you know, AESA is a highly respected national association serving educational services agencies in 45 states, representing more than 553 member agencies. The Executive Council is the governing body for our association and there is no better way to serve the association and its members than serving on the Executive Council! The Council provides oversight to all aspects of the association: from advocacy efforts in Washington, D.C., the continued development of a strong business relations program, membership service activities like the annual conference, to the support of various research and development initiatives. Serving on the Executive Council provides a great opportunity to influence and lead AESA!

Leadership, commitment, hard work, and loyalty all describe the attributes of Council members. Past Council members describe their experience serving on the Executive Council as having been one of the most impactful and meaningful experiences in their educational career. Great work leads to great friends and the opportunity to engage in Council work is well worth your consideration. I would encourage you to consider running for the Council.

AESA Bylaws, Article III, Section (b) states "In order to maintain 12 Council members and have four-year terms of office each region elects Council members three out of four years. The election sequence will be determined by the Council with each region having a bye every four years."

This year the Western Region has the bye and will not have a nominee. The states in the Western Region are Alaska, Arizona, California, Colorado, Hawaii, Idaho, Kansas, Montana, New Mexico, Oregon, Utah, Washington, and Wyoming. These states will, however, have the opportunity to vote in the national election. This year's national nominations must come from the Central, Eastern, and Southern regions. You also must be the Superintendent/CEO of an ESA in order to run for the Executive Council.

All nomination materials can be found on the AESA website www.aesa.us. I urge you to give careful consideration to running for a Council position. Nominations, biographical statements, signed pledge letter, and a digital picture are due by September 2, 2016.
